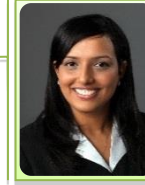

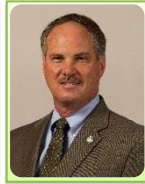

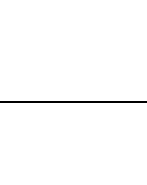

**A Conference, An Honoring of Heroes,
and a Complete Transportation System**

The US High-Speed Rail Association (www.ushsr.com), a Washington DC-based nonprofit that “builds widespread public, business, and political support for a major investment in a nationwide High Speed Rail network” held a West Coast Rail Conference at LA Metro Headquarters between April 30 and May 2. There were two days of educational sessions followed by a day of technical tours. This event attracted well over 100 attendees from around the world and featured 11 educational sessions, 30 presentations, and 26 sponsors along with exhibits in the boardroom lobby and posters positioned throughout the boardroom featuring High Speed Rail innovations, heroes, and transit-oriented development photographs.

Session highlights were as follows:

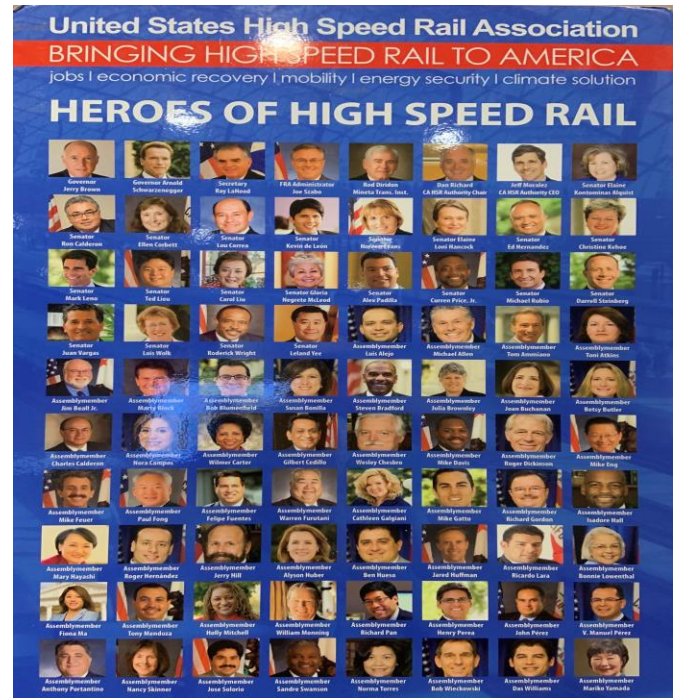

2. High Speed Rail Around the World featured Jean-Pierre Loubinoux (UIC), Benjamin Dobernecker (Siemens), Scott Sherin (Alstom), Juan Pablo Barahona (Talgo), and Juan Matias Archilla Pintidura (Renfe).
3. California High Speed Rail – America’s Mega Project featured Karen Philbrick (Mineta Transportation Institute), Michelle Boehm (California High Speed Rail Authority), and Stephanie Wiggins (Metrolink).
4. New Money for Rail – Public & Private featured John Morton (Global Infrastructure Partners) and Denny Zane (Move LA).
5. TOD – Future Trends in Real Estate & Rail featured Jeanet Owens (LA Metro) and Michael Dieden (Creative Housing Associates).
6. Getting Stations Right – Design for Walkability, Placemaking, & Community featured Andrew Byrne (Grimshaw Architects), Vinayak Bharne (Moule Polyzoides Architects & Urbanists), and Brian O’Looney (Torti Gallas Architects).
7. Urban Rail – Scaling Up for \$180 Billion in Projects featured Bryan Pennington (LA Metro), John Douglas (Balfour Beatty Infrastructure), and Diego de la Garza (City of Los Angeles).
8. Special Keynote Presentation featured Vinay Mudholkar (Rail and Program Management US and International Technology Transfer).
9. Rail Technology & Global Best Practices featured Inaki Barron (Renfe).
10. High-Speed Rail: The Silver Bullet: Transforming Travel, Employment, Living Options featured Dow Constantine (King County, Washington), Takayoshi Oshima (Allied Telesis), and Andrea Giuricin (TRA Consulting).
11. Transforming US Transportation Policy featured Thea Selby (Next Steps Marketing), Denny Zane (Move LA), and Steve Larsen (California Strategies).

There was a poster displayed prominently in the Metro Boardroom dating back to July 2012 honoring a total of 80 high-level executives and elected officials who were instrumental at getting California High Speed Rail through both the Assembly and Senate. A few hero highlights are as follows:

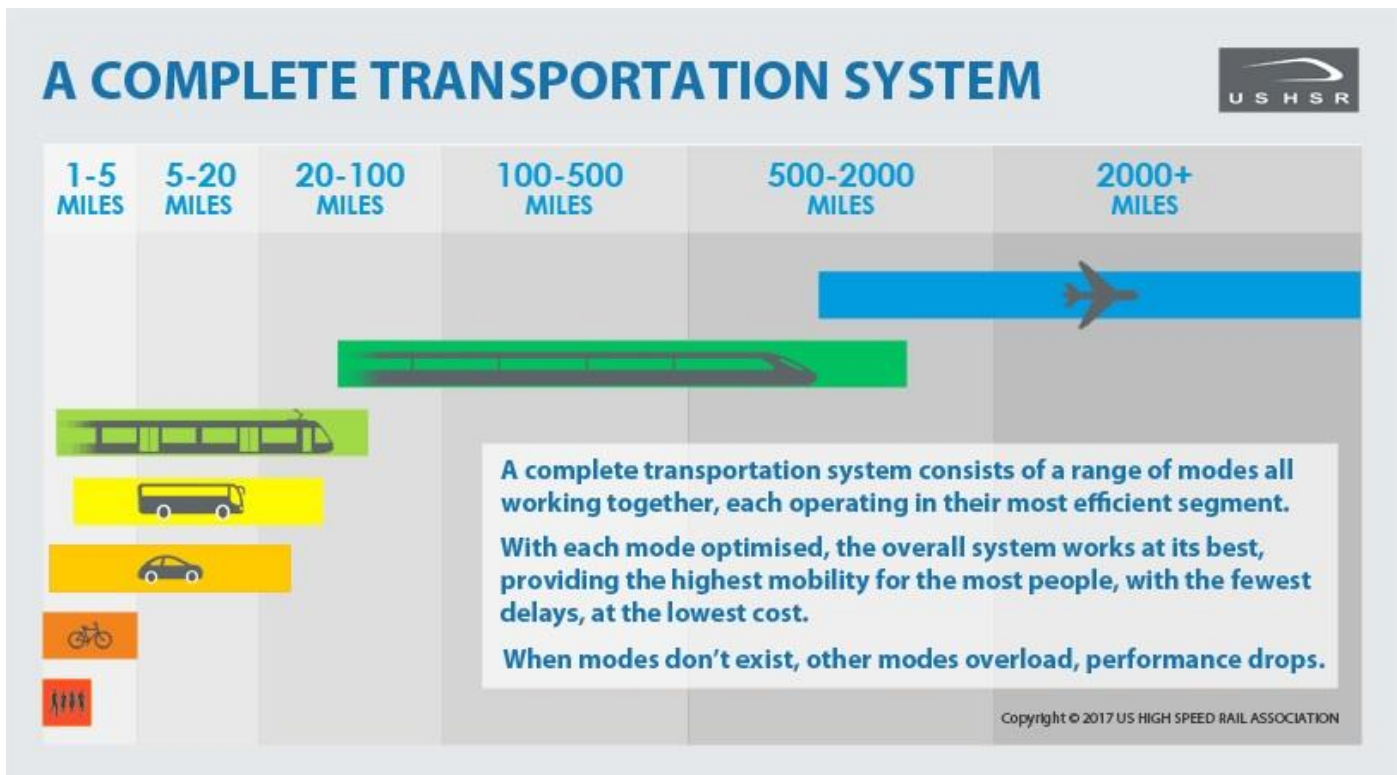
1. Senate President Pro Tem Darrell Steinberg’s quote, “With all 15 Republicans and 4 of the Democrats opposed, there was no room to spare...had to get everybody else”, was prominently displayed on the front page of *The Sacramento Bee* on Saturday, July 7, 2012.
2. Senator Leland Yee cast the deciding vote on High Speed Rail in the Senate resulting in the 21 votes necessary for passage.

3. Assembly members Cathleen Galgiani and Fiona Ma are widely regarded as the “Thelma and Louise of HSR”, as they were instrumental in getting the HSR measure onto the ballot back in 2008.
4. Dan Richard served as Chair of the High-Speed Rail Authority Board of Directors between February 2012 and February 2019; and is now Chair of the US High Speed Rail Association’s Advisory Board.

5. Governor Arnold Schwarzenegger reminisces on his “body building days” riding the Japanese Shinkansen while declaring that “failure is not an option” for making this technology a reality in the United States.

Attendees making the 220-mile drive home to Fresno ("The Birthplace of True HSR in America") from the Conference would have been especially intrigued with a 90-minute travel option and a meal in route versus a 5-hour/300-minute journey entailing a drive within heavy traffic plus a meal and gas stop.

On Thursday, April 18, **Ashley Kim** from DKS Associates and **Shannon Nguyen** from BKF Engineers co-presented at the Cal Poly Pomona ITE Student Chapter meeting. They presented on an intersection improvement project in the City of Irvine, CA, where they explained the traffic signal design process as well as their experiences in college, the workforce, and in professional organizations.

They encouraged the student members to pursue EIT certification and discussed upcoming internship opportunities at their companies. They also advised the younger generation of engineers to stay involved with ITE as students and as young working professionals; and encouraged them to serve on committees or as officers; and attend local and regional ITE meetings and conferences.

ITE So-Cal's April Luncheon *Bryan Luong (Michael Baker International)*

ITE SoCal's April Luncheon was held on Wednesday, April 17, 2019 at the Luminarias Restaurant in Monterey Park. To begin the meeting of over 30 transportation professionals in attendance, the ITE SoCal President, Josh McNeill, called the meeting to order and made a few announcements for the Western District ITE and SoCal ITE:

- Registration for the Western District Meeting in Monterey Bay is currently open. The meeting will be held at the Hyatt Regency Hotel and Spa on Del Monte Golf Course from June 22 to June 26, 2019. Vendor booths and sponsorships are still available.
- The Annual Student Night hosted by ITE SoCal with OCTEC will be held on May 22, 2019 at 6:45PM at the Knott's Berry Farm Hotel in Buena Park. There will be approximately 100 students from the SoCal ITE student chapters in attendance, as well as a career fair prior to the event from 5:30PM to 6:30PM. There are currently seven career fair booths reserved and three open booths for more companies to be involved. Contact Josh McNeill or any of the ITE SoCal board members if your company is interested.
- The Annual Business Meeting and Mini-Workshop hosted by ITE SoCal with ITS CA will be held on June 19, 2019. The new ITE SoCal board will be sworn in and recipients of the Classic Engineer Award and Young Transportation Engineer Award will be announced at this meeting. The workshop will be discussing mobility as a service, one of the new initiatives established by ITE International.

Josh introduced the meeting sponsor of the month, KOA. **Min Zhou** of KOA presented the company's services and work in transportation engineering and design, planning, active transportation, and construction management.

Josh then introduced the meeting speaker, **Dapeng Zhang**, on: "Making Hyperloop a Reality." As the Lead Transportation Economist for Virgin Hyperloop One, Mr. Zhang is responsible for the economic analysis of the hyperloop system and focuses on strategizing business endeavors, such as fundraising and bringing hyperloop into the market. He works directly with consultants, governments, investors, and engineers to promote hyperloop technology in multiple countries. The goal is to make hyperloop the next phase of transportation in the similar vein as automobiles for personal mobility and airplanes for global connections.

Virgin Hyperloop One is the only company to do full scale hyperloop testing and is currently evaluating the first-mile/last-mile issue and improving the user experience. Mr. Zhang discussed the use of ridesharing apps and traffic management systems at stations to service and inform riders. Since each pod holds approximately 24 to 28 people, the number of stops can be optimized, and pods can bypass stations at intermediate stops. Through hyperloop's use of levitating pods pushed by electromagnetic forces and the ability to be run autonomously, the cruising speed is approximately 670 mph. Mr. Zhang noted that hyperloop would have a lower lifetime cost than planes and high speed rail at all speeds due to the use of the pods in low pressure tubes.

Hyperloop currently has its biggest presence in India, but the company's vision is to connect 80% of the American population in 5 hours or less. Right now, the state of Colorado is partnering with Virgin Hyperloop One to study the feasibility of a statewide hyperloop network. The study is expected to be completed by the summer of 2019, and will capture wait time lengths as well as compare cost estimates with other modes of transportation. During this time of testing, the target audiences are high income individuals and high priority individuals, such as airline travelers.

May 2019 Legislative Analysis

Here is an update on transportation-related bills in the Legislature:

- **AB-1243 (Fong)** also known as the Traffic Relief and Road Improvement Act, would utilize existing sources of revenue from the Motor Vehicle Account, commercial motor vehicle weight fees, and fuel taxes to create a specific fund to address traffic congestion and deferred state highway maintenance. The bill would also prohibit CEQA from applying to a project or project permit that consists of the inspection, maintenance, repair, rehabilitation, and/or removal of existing transportation infrastructure, or to the addition of an auxiliary lane or bikeway to existing transportation infrastructure. (Status: Active Bill – In Committee Process)
- **SB 662 (Archuleta)** would require the Public Utilities Commission and Energy Commission to explore opportunities to increase grid-responsive production of green electrolytic hydrogen for use in the transportation sector. (Status: Active Bill – In Committee Process)
- **SB-59 (Allen)** which would establish guiding principles for autonomous vehicles to ensure they don't detract from the State's VMT and GHG reduction targets, was amended to require a working group to submit its recommendations for policy development to the Legislature on or before January 1, 2021. (Status: Active Bill – In Committee Process)
- **SB-526 (Allen)** which would require MPOs to assign lower priority to transportation projects that would increase VMT and GHG emissions, was amended to include land use parameters as well. (Status: Active Bill – In Committee Process)

Road Safety Professional Level 1 and 2 Now Available

For transportation professionals seeking certification in the safety field, ITE is offering the Road Safety Professional (RSP) Level 1 and 2

certification with the first RSP2 and third RSP1 testing date taking place October 1 to 31, 2019 (applications must be received by midnight, August 6, 2019). Applications will be available by the end of April for RSP2.

This certification is geared toward professionals whose primary job functions are directed at improving the safety performance of the surface transportation system. It is for professionals responsible for developing and implementing engineering or behavioral programs aimed at reducing the number of fatalities and injuries due to road crashes.
