#### High Speed Rail and Millennials David M. Schwegel, PE

"This is our turn. Previous generations have given you the transportation systems that you enjoy. It's your generation's turn to give to our generation. High Speed Rail (HSR) represents how we will access our employment and vacation destinations. We'll pay for it. Just get it up and running."

This was the consistent message conveyed by numerous students from the UC Merced I Will Ride HSR (www.iwillridehsr.com) Student Alliance at the California High Speed Rail Authority

(CHSRA, <u>www.hsr.ca.gov</u>) Board Meeting in San Francisco in April 2012. CHSRA Vice-Chair Lynn Schenk agreed. "This is our turn to give to their generation."

Millennials (born between 1982 and 2000) from CSU LA and Cal Poly Pomona were well represented among the volunteers and delegates (sponsored by firms such as Kimley-Horn) at the US High Speed Rail (USHSR) (www.ushsr.com) Conference at the LA Metro Headquarters Board Room, November 5-7, 2013. Student volunteers included Sophrinia Cassell, Debra Dickerson, Nazanin Hajaty, Martin He, Annette Martinez, Alexander Mezey, Joshua Park, Raphael Perez, Fabiola Ramirez, Yvainne Valenzuela, and Bowen Yang. Thank you for your valuable role in the success of this conference which attracted over 200 delegates worldwide.

All generations, especially Millennials, are encouraged to check out: (a) USHSR Conference videos (<u>www.ushsr.com</u>), and (b) California-specific information (www.hsr.ca.gov). project Conference video highlights include Jeff Morales and Ron Tutor on "Bringing HSR to California", California Senator Cathleen Galgiani and Assemblymember Fiona Ma on the legislative perspective on HSR, and Caltrans Director Malcolm Dougherty on HSR's impacts on the state highway system. California-specific project highlights include the project's role in the California State Rail Plan (2013). Also, keep an eye on HSR curricula to be integrated into university degree programs, especially those at UC Merced, CSU Bakersfield, and CSU Fresno. An October 2013 Meeting with Evelyn Young of CSU Bakersfield's Office of the President suggests an HSR Information and Simulation Center may also be in the works once additional progress has been made on the curriculum.

#### Measure R Update

Measure R has resurfaced in the news and discussions within the Los Angeles community. County transportation officials are working on a new ballot measure for either 2015 or 2016. This measure would increase the county's sales tax by half a cent or extend the life of Measure R. The current expiration date is 2039. Similar offerings have been made before. Last year, a proposal to extend the life of Measure R failed in a close call.

#### AB 1243 Employment: Taxi Drivers

This bill would designate the driver of a taxicab as an independent contractor rather than an employee of the taxi company. The bill would also specify the factors that may and may not be considered as evidence of employer-like control by a taxi company.

#### AB 466 Federal Transportation Funds

Currently certain federal transportation funds may be apportioned to the state for specified purposes administered by the California Transportation Agency (CTA) as well as local and regional programs administered by diverse regional agencies, including Congestion Mitigation and Air Quality (CMAQ) Improvement Program funds. AB 466 would require the CTA to allocate federal CMAQ funds to regional agencies according to population and pollution characteristics.

#### AB 92 State Government

There is a Transit-Oriented Development (TOD) Implementation Fund. The Department of Housing and Community Development currently uses this TOD fund to provide grants and loans to municipalities, municipal transit agencies, and developers to develop or facilitate the development of higher density uses near transit stations to boost public transit ridership. Currently, some of this TOD funding may be used for liquidation of encumbrances. AB 92 would extend the period of time that these funds could be available for this purpose until June 30, 2017, provided that performance-based milestones are met.

#### Trivia Corner: "Colorado Street" Andrew Maximous, PE, TE, City of Santa Monica

ITE So Cal Past-President

Happy New Year! As all eyes turn to Pasadena every January 1, let's take a look back at the rich history of Colorado Boulevard.

Today, Colorado Blvd extends through five Cities (Los Angeles, Glendale, Pasadena, Arcadia, and Monrovia) from the Golden State Freeway (I-5) at the west to Recreation Park in Monrovia at the east.

The original name of the roadway was Colorado Street and the first segment was built in the mid 1800's from Orange Grove Boulevard to Arroyo Parkway (today's "Old Town" Pasadena). The City of Glendale still keeps the original name; the City of Pasadena renamed it to "Boulevard" in 1958.

The iconic Colorado <u>Street</u> Bridge has also kept its original name. The Bridge was designed and built in 1913 to cross the Arroyo Seco; it has been in service for 100 years! Upon its completion it was hailed as the longest and tallest bridge in Southern California. It was listed on the National Register of Historic Places in 1981.

Between Santa Anita Ave and Fair Oaks Ave, Colorado Blvd was part of the original Route 66. The route was adopted in 1926 and decommissioned in 1972. The US 66 shields began to come down in 1975, soon after the Foothill Freeway (I-210) was completed.

At the western end, Colorado Street begins at the Golden State Freeway (I-5) as a short freeway spur, originally carrying State Route 134 until it was moved north onto the Ventura Freeway.
